Spotlight on Nursing and Midwifery: Underpinning research

In <u>'Spotlight on Nursing and Midwifery 2024'</u>, we share insights drawn from data we hold, external research literature, and key pieces of further research that we have undertaken. This includes:

- A survey of professionals, students, employers and members of the public Surveys of:
 - 2,939 nursing and midwifery professionals
 - 1,014 students on our approved programmes
 - 59 employers
 - 2,016 nationally representative members of the public
- 2. Qualitative research with members of the public

An online community with 20 people from minority ethnic backgrounds (an online community is a group of people taking part in a series of conversations and structured exercises around a given topic) and seven in-depth interviews with disabled people.

- 3. Analysis of a sample of fitness to practise concerns received from members of the public including:
 - Analysis of fitness to practise concerns raised with us relating to continuing healthcare¹, April 2014-August 2020
 - Analysis of fitness to practise concerns raised with us by members of the public, January 2014-March 2023 including an in-depth qualitative review of 191 concerns

More information about the survey and qualitative research is provided below (which expands on points one and two above).

NHS continuing healthcare (CHC) is a package of ongoing care, for adults aged 18 and over, provided outside hospital. It is arranged and funded solely by the NHS, where it has been assessed that someone's need for care is primarily due to their health needs (a 'primary health need'). It is designed to meet physical and/or mental health needs that have arisen because of disability, accident or illness. CHC exists in England and Wales and there is equivalent provision in Scotland and Northern Ireland.
