- February 2013 report published
- March 2013 Government's initial response
- July 2013 Our full response, including an action plan
- November 2013 Government's full response due to be published



The Francis report: Our planned actions

- Raising our public profile
- Improving our effectiveness and efficiency through changes to our legislation
- Improving joint working and intelligence sharing
- Improving witness experience
- Evaluating our pre-registration education standards
- Reviewing the Code and other practice standards
- Introducing regional advisors to provide local liaison



Other healthcare reviews

 The Cavendish Review, The Keogh Review, The Berwick Review and Clwyd/Hart Review

We:

- Have responded to these reviews
- Have committed to visiting 11 of the Keogh trusts by the end of 2013
- Are members of the Department of Health-led patient safety working group



Professional Standards Authority (PSA)

- Annual performance review looks at four regulatory functions and 24 standards of Good Regulation
- For 2012-201 we met 16 of the 24 Standards

2013-2014:

- Review underway, evidence submitted in December

- Report published June 2014



Health Select Committee

- We submit our annual reports
- PSA and other interested parties also submit evidence
- Most recent hearing October 2013
- Report and recommendations in December 2013

Launch of Quality assurance framework

- Outcome focused
- Clarifies roles of other organisations
- Proportionate, risk based approach
- Responding to concerns
- Exceptional reporting





Revalidation

- Three options presented for phase 1- within current legislation
- Option 3 clear steer by stakeholders as preferred option based on benefits
- Self Confirmation from the individual registrant which is informed by third party input and based on enhanced Code and standards
- · We will perform audit and triangulation



Revalidation and the revised Code

- Commitment to include feedback from patients, service users and peers to improve practice
- A new Code and guidance will support how nurses and midwives demonstrate their continued fitness to practise
- Six-month period of intensive consultation starting in the New Year
- Pre-consultation engagement on-going
- Working together to engage patient and public views

Towards a strategy for the NMC

- Council and Executive considering its strategy for the next five years (2014-19)
- Away day on 24 October
- Staff day on 17 January
- External engagement through opporunites such as this
- Approval and publication in March 2014



Existing commitments

- Code review in 2014
- Fitness to practise legislation changes in 2014
- Fitness to practise improvements by end of 2015 and then more challenging targets after that
- Revalidation by end of 2015
- IT strategy delivered over next three years
- Financial targets by 2016



External strategic context – what is on the horizon?

- Possible Law Commission Bill containing improvements to healthcare regulation legislation
- New EU directive be transposed into UK law
- Scottish referendum
- General elections across the UK



External strategic context – 'Francis fallout'

- Continued impact of Francis and other inquires / reports into failings in care
- Need for NMC to deliver Francis commitments including
 - Raising our profile with patients and the public
 - Better collaborative working between system and professional regulators



Likely direction of travel

- Continuing to focus on protecting the public better
- Registration and fitness to practice improvement
- Getting the right legislation to help us regulate well
- Efficiencies
- Reducing unit cost
- Investing in IT to improve efficiency and effectiveness
