Decision and reasons on interim order

The panel decided to confirm the current interim conditions of practice order.

The panel has determined that the following conditions are proportionate and appropriate:

For the purposes of these conditions, 'employment' and 'work' mean any paid or unpaid post in a nursing, midwifery or nursing associate role. Also, 'course of study' and 'course' mean any course of educational study connected to nursing, midwifery or nursing associates.

1. You must only work as a registered nurse for South Eastern Health and Social Care Trust under the strict supervision of the Trust Oversight Group.
2. You must not undertake any bank or agency work.
3. You must keep the NMC informed about anywhere you are studying by:
 - a) Telling your NMC Case Officer within seven days of accepting any course of study.
 - b) Giving your NMC Case Officer the name and contact details of the organisation offering that course of study
4. You must immediately give a copy of these conditions to South Eastern Health and Social Care Trust and the Trust Oversight Group.
5. You must tell your NMC Case Officer, within seven days of your becoming aware of:
 - a) Any clinical incident you are involved in.
 - b) Any investigation started against you.
 - c) Any disciplinary proceedings taken against you.
 - d) If for any reason your employment has terminated.

6. You must allow your NMC Case Officer to share, as necessary, details about your performance, your compliance with and / or progress under these conditions with:
 - a) The South Eastern Health and Social Care Trust and the Trust Oversight Group.
 - b) Any educational establishment.
 - c) Any other person(s) involved in your retraining and/or supervision required by these conditions.

7. You must send your NMC Case Officer in advance of any NMC review of your case, a report from your line manager, mentor or supervisor regarding your practice and current role within the Trust.

Unless Mr Shields' case has already been concluded, this interim order must be reviewed before the end of the next six months and every six months thereafter. Additionally, Mr Shield or the Nursing and Midwifery Council (NMC) may ask for the interim order to be reviewed if any new evidence becomes available that may be relevant to the interim order.

At any review a panel may revoke the interim order or any condition of it, it may confirm the interim order, or vary any condition of it, or it may replace the interim conditions of practice order with an interim suspension order.

The NMC Case Examiners are yet to decide whether there is a case to answer in relation to the allegations made against Mr Shield. The NMC will write to Mr Shield when the case is ready for the next stage of the fitness to practise process.

This will be confirmed to Mr Shield in writing.

That concludes this determination.
